Report on the Audit of the Standalone Financial Statements

Opinion

We have audited the accompanying standalone financial statements of **JDM COMMERCIAL PRIVATE LIMITED** (the "Company"), which comprise the Balance Sheet as at May 31, 2022, the Statement of Profit and Loss (including Other Comprehensive Income), the Statement of Changes in Equity and the Statement of Cash Flows for the year ended on that date and a summary of significant accounting policies and other explanatory information (hereinafter referred to as the "standalone financial statements").

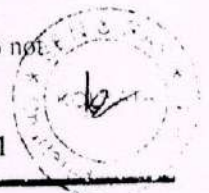

Auditor's Responsibilities for the Audit of the Standalone Financial Statements

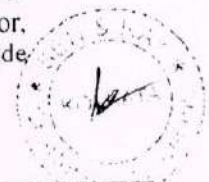

 - iii. There were no amount which were required to be transferred to the Investor Education and Protection Fund by the Company.

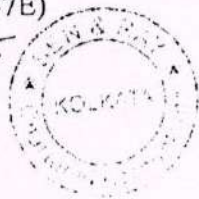
